- **Driveways must be clear of snow and ice for safe delivery.**
- **The customer is ultimately responsible for ascertaining the tank level.**
- **After hour delivery fee \$400.00 - Same day delivery \$200.**
- **Petro Serve USA has the right to deliver all remaining pre-buy contracted gallons before period ending date.**
- **200 GALLON MINIMUM PURCHASE**

The Contract Period ends **April 28th 2023** Petro Serve USA shall have the right to repurchase any remaining gallons at that time.

This Contract must be fulfilled by patron during the Specified Time Period. In no circumstances will Petro Serve USA agree to a request to rebill deliveries outside the Specified Time Period of the Agreement. In the event that patron fails to fulfill all the terms and conditions of the Agreement, Petro Serve USA shall have the right to charge a cancellation/default penalty to patron. The amount of such penalty shall be the greater of: (a) the per gallon amount by which the agreement's final price, as stated above, exceeds the Petro Serve USA posted daily price on the last day of the Specified Time Period or (b) twenty (20) cents per gallon on all gallons included in the quantities covered by the Agreement that patron failed to receive during the Specified Time Period. **Any pre-paid funds remaining at that time will revert to patron's open account to be used on future pre-buy contract purchase.**
